# PhD Student Payroll Processing Frequently Asked Questions

# 1. What do the codes on my paycheck mean?

What may appear on your check:	What it means:	Appointment Letter Type
EARNINGS/FELLOWSHIPS: Salary	Pay for PhD students who receive a wage	Guaranteed Funding
EARNINGS/FELLOWSHIPS: Fellowship	Pay for PhD students who receive a fellowship stipend	Guaranteed Funding
EARNINGS/FELLOWSHIPS: Regular	Additional pay in these categories: Regular Pay, Standard Overtime, Regular Non-Federal Work Study, MD Safe and Sick Leave	Non-guaranteed, hourly or flat rate/fixed term for a time period (e.g., per semester)
EARNINGS/FELLOWSHIPS: Ratification Bonus OR RatifyBnsFellowship	Additional pay to PhD students who received any payment from JHU at the time of ratification of the TRU Collective Bargaining Agreement. The amount will appear on your check as "Ratification Bonus".	Additional pay
	PhD students receiving only fellowships at the time the bonus is paid will have the bonus paid as a fellowship. The amount will appear on your check as "RatifyBnsFellowship".	

Just because taxes are not withheld, does not mean the funds are not taxable. You may owe taxes on these funds. Please get more information at <a href="IRS.gov">IRS.gov</a>.

#### 2. What is the PhD Ratification Bonus?

<u>Each bargaining unit employee</u> as of the date of ratification of the TRU Collective Bargaining Agreement will receive <u>a one-time lump sum payment of \$1,000</u>, less all applicable federal and state tax withholdings, from the University on <u>your May 15 paycheck</u>.

#### 3. Will the PhD Ratification Bonus have taxes withheld?

Yes, except as described immediately below, the University will withhold all applicable federal and state taxes on the Ratification Bonus.

Exception: PhD students who are (1) U.S. tax residents and (2) only receiving fellowships at the time the Ratification Bonus is paid, will not have any taxes withheld on the bonus. The Ratification Bonus constitutes an additional fellowship payment and should be considered a fellowship payment when completing your 2024 tax filings. For more information about fellowships and taxes please see the Tax Office Website.

Exception: The University will honor any treaty facilitation already in place for International PhD students. Where a treaty is being facilitated, this could result in no tax being withheld at the federal and possibly the state level.

## 4. How much tax is being withheld from the PhD Ratification Bonus?

As addressed in 3 above, taxes will generally be withheld on the Ratification Bonus.

Federal taxes withheld will be at the 22% supplemental rate. State taxes will be withheld based on your withholding information on file and will follow the applicable state withholding tables. If you are a nonresident PhD and the University is facilitating a treaty for you, we will honor the treaty and this could reduce withholding.

Exception: Nonresident PhD students who are receiving only fellowships at the time the Ratification Bonus is processed will have federal taxes withheld at the 14% flat rate. State taxes will be withheld based on your withholding information on file and will follow the applicable state withholding tables. If the University is facilitating a treaty for you, we will honor the treaty and this could reduce withholding.
